ORDINANCE NO. 135 OF 1972

BY MAYOR ALLEN:

An ordinance amending Ordinance No. 184 of 1957 of the City of Shreveport, La., by changing the zoning classification of a tract of land located on the West side of North Market, opposite Barton Drive, from I-2, Heavy Industry District to B-3, Community Business District with the building having Municipal Number 1701 North Market Street being rezoned from B-3, Community Business District to B-3-L-2, Liquor District.

SECTION I: BE IT ORDAINED by the City Council of the City of Shreveport, Louisiana, in legal and regular session convened, that a parcel of land in Section 23, T18N, R14W, Shreveport, Caddo Parish, Louisiana, beginning at a point where the North line of said Section intersects the SW line of North Market Street, run thence Southeasterly along the Southwest line of North Market Street a distance of 1,231.19 feet to the point of beginning of tract herein described; run thence S. 57° 13' 15" W. a distance of 250 feet, run thence in a Southeast direction, 250 feet from and parallel to the Southwest line of North Market Street a distance of 282.6 feet, run thence N. 54° 45' 15" E. a distance of 100 feet, run thence N. 34° 16' W. a distance of 154.1 feet, run thence North 56° 14' 25" E. a distance of 150 feet to a point on the SW line of North Market Street, run thence in a Northwesterly direction along the Southwest line of North Market Street a distance of 121.4 feet to the point of beginning, located on the West side of North Market, opposite Barton Drive, be and the same is hereby changed from I-2, Heavy Industry District to B-3, Community Business District.

SECTION II: BE IT FURTHER ORDAINED, Etc., that the building having Municipal Number 1701 North Market Street, be and the same is hereby changed from B-3, Community Business District to B-3-L-2, Liquor District.
