INDICATED IN THE BODY OF THIS ORDINANCE.

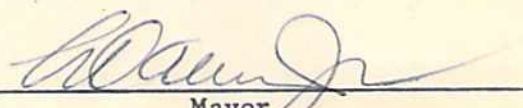
SECTION 1: BE IT ORDAINED by the City Council of the City of Shreveport in

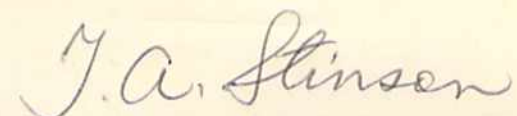

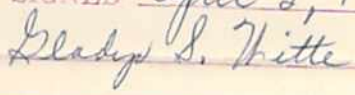
