ORDINANCE NO. 8 OF 1972

By Mr. D'Artois:

AN ORDINANCE REPEALING AND RE-ENACTING SECTION 1, SECTION 2 AND SECTION 3 OF ORDINANCE NO. 18 OF 1943, AND ORDINANCE NO. 23 OF 1945, BEING ORDINANCES TO REGULATE TRAFFIC AND PROMOTE SAFETY BY REQUIRING THE USE OF CERTAIN STREETS AND ESTABLISHING ROUTES ALONG CERTAIN STREETS FOR HEAVY COMMERCIAL VEHICLES USING THE STREETS AND ALLEYS OF THE CITY OF SHREVEPORT.

SECTION 1: BE IT ORDAINED by the City of Shreveport in regular and legal session convened, that Sections 1,2 and 3 of Ordinance No. 18 of 1943, and Ordinance No. 23 of 1945 be repealed and re-enacted to read as follows:

I.

Routes connecting the Texas Street bridge across Red River with:

- a) U.S. Highway No. 71 and La. Highway No. 1 north of the city; Spring Street to North Market Street; reverse is North Market Street to Market Street to Texas Street.
- b) U.S. Highway No. 79 and 80 west of the City and U.S. Highway No. 171 south of the city and the Cedar Grove area; Spring Street to Caddo Street; Caddo Street to Ford Street; Ford Street to Hearne Avenue; Hearne Avenue to Greenwood Road (U.S. Highway 80) and to Mansfield Road (U.S. Highway 171); use 70th Street (La. Highway 511) to connect U.S. Highway 171 with the Cedar Grove area and reverse.
- c) Interstate 20, Market Street to Interstate 20; reverse Interstate 20 to Spring Street; Spring Street to Texas Street.
- d) La. Highway 3032 east of city; Market Street to Youree Drive; Youree Drive to East Kings Highway; East Kings Highway to Shreveport-Barksdale Highway (La. Highway 3032).

Reverse La. Highway 3032 to East Kings Highway to Youree Drive;
Youree Drive to Spring Street; Spring Street to Texas Street.

- e) La. Highway No. 1 and La. Highway 523 south of city; Market Street to Youree Drive; Youree Drive to La. Highway No. 1; Use 70th Street to connect La. Highway No. 1 with La. Highway 523. Reverse use 70th Street to connect La. Highway 523 with La. Highway No. 1; La. Highway No. 1 to Youree Drive; Youree Drive to Spring Street; Spring Street to Texas Street.

II.

Routes connecting U.S. Highway 71 north of city with:

- a) U.S. Highway 80 and Interstate 20 West; Hearne Avenue to Greenwood Road (U.S. Highway 80) and Interstate 20 and reverse.
- b) U.S. Highway 171; La. Highway 511; and La. Highway 523 south of city; Hearne Avenue to Mansfield Road (U.S. Highway 171); and Mansfield Road to 70th Street (La. Highway 511); use La. Highway 511 to connect La. Highway 523 with U.S. Highway 171 and reverse.
- c) Interstate 20 East; La. Highway 3032; and La. Highway No. 1 east of city; North Market Street to Market Street; Market Street to Interstate 20; Market Street to Youree Drive (La. Highway No. 1); Youree Drive to East Kings Highway; use East Kings Highway to connect La. 3032 with Youree Drive (La. Highway No. 1). Reverse is Youree Drive to Spring Street; Spring Street to Market Street; Market Street to North Market.

III.

Routes connecting U.S. Highway 80 West of city with:

- a) U.S. Highway 171; La. Highway 511; La. Highway 523; and La. Highway No. 1 south of city; Hearne Avenue to Mansfield Road (U.S. Highway 171); Mansfield Road to 70th Street (La. Highway 511); use La. Highway 511 to connect U.S. Highway 171 with La. Highway 523 and La. Highway No. 1.

b) La. Highway 3032 East of city; U.S. Highway 80 to Interstate 20; Interstate 20 to Spring Street; Spring Street to Lake Street; Lake Street to Market Street; Market Street to Youree Drive; Youree Drive to East Kings Highway; East Kings Highway to La. Highway 3032. Reverse is La. Highway 3032 to East Kings Highway; East Kings Highway to Youree Drive; Youree Drive to Spring Street; Spring Street to Crockett Street; Crockett Street to Market Street; Market Street to Interstate.

IV.

Routes connecting U.S. Highway 171 south of city with:

La. Highway 3032 east of city; 70th Street to Youree Drive; Youree Drive to East Kings Highway; East Kings Highway to La. Highway 3032 and reverse.

February 8, 1972 - REad by title and as read, passed first reading by the following vote: Ayes; Mayor Allen, Commissioners Burton, D'Artois, Collins and Hathaway 5. Nays: None.

February 22, 1972 - Having passed first reading on February 8, 1972 - was read by title and on motion ordered passed to third reading. Read the third time in full and as read, adopted by the following vote: Ayes; Mayor Allen, Commissioners Burton, D'Artois, Collins and Hathaway 5. Nays: None.
