Ordinance Closing and Abandoning the Twenty Foot
(20') Alley in Block 22, J. N. Howell Subdivision

By Commissioner Hathaway:

WHEREAS, the City Council of the City of Shreveport has received a petition signed by the owners of all property abutting the twenty foot (20') alley in Block 22, J. N. Howell Subdivision, as filed and recorded in Book P, Page 911, Conveyance Records of Caddo Parish, Louisiana, requesting the closure and abandonment of said alley; and

WHEREAS, all affected utility companies have agreed to this closure and abandonment; and

WHEREAS, this closure and abandonment will best serve all concerned closed and abandoned.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, in legal and regular session convened, that the twenty foot (20') alley in Block 22, J. N. Howell Subdivision, be and it is hereby closed and abandoned.

BE IT FURTHER ORDAINED, etc., that this Ordinance be filed in the records of Caddo Parish, Louisiana.

Second and Final Reading: March 28, 1972

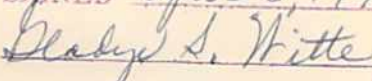
