

ORDINANCE NO. 1 OF 1972

AN ORDINANCE CREATING SEVENTEEN (17) STOP INTERSECTIONS WITHIN THE CITY LIMITS OF THE CITY OF SHREVEPORT AS INDICATED IN THE BODY OF THIS ORDINANCE AND PROVIDING PENALTY FOR THE VIOLATION OF THIS ORDINANCE.

SECTION 1: BE IT ORDAINED by the City Council of the City of Shreveport in regular and legal session convened, that the following intersections are hereby made and created stop intersections:

| 8. 74th Street and Union Street | Stop at Union Street |
| 9. 75th Street and Union Street | Stop at 75th Street |
| 10. Pinetree Drive and 75th Street | Stop at 75th Street |
| 11. Browning Street and Woodfield Drive | Stop at Woodfield Drive |
| 12. Wingate Circle and Woodfield Drive | Stop at Woodfield Drive |
| 13. Argyle Street and Woodfield Drive | Stop at Woodfield Drive |
| 14. Harrison Street and Woodfield Drive | Stop at Woodfield Drive |
| 15. Melrose Street and Woodfield Drive | Stop at Woodfield Drive |
| 16. Browning Street and Clift Street | Stop at Browning Street |
| 17. Lanny Lane and Bringhurst Drive | Stop at Bringhurst Drive |

SECTION 2: BE IT FURTHER ORDAINED, etc., that for the violation of this ordinance and upon conviction thereof in the City Court of Shreveport there shall be assessed a fine of not more than Twenty-Five (\$25.00) Dollars. In case of failure to pay said fine the same shall be worked out upon the public works of the City of Shreveport at the rate of \$5.00 per day.
