

ORDINANCE NO. 126 OF 1972

AN ORDINANCE TO CLOSE AND ABANDON
THE CUL-DE-SAC ON THE WEST END OF
JOFFRION DRIVE AS DEDICATED ON MAP
IN BOOK 1200, PAGE 347

By Commissioner Hathaway:

WHEREAS, the City Council of the City of Shreveport has received a request to close and abandon the cul-de-sac on the Westerly end of Joffrion Drive as filed and recorded on map in Book 1200, page 347, and as shown on the print attached hereto to be closed and abandoned; and

WHEREAS, the owner of all property abutting this part of Joffrion Drive has signed the plat requesting this closure and abandonment; and

WHEREAS, the owner has agreed to dedicate an additional cul-de-sac, as shown on the plat attached hereto "herein dedicated".

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, in legal and regular session convened, that that part of Joffrion Drive being the cul-de-sac as dedicated and recorded in Book 1200, page 347, and as shown on the plat attached "herein closed and abandoned" be and it is hereby closed and abandoned.

BE IT FURTHER ORDAINED, etc., that the plat showing an additional dedication for a cul-de-sac on Joffrion Drive as per plat attached hereto be and it is hereby approved for recording.

BE IT FURTHER ORDAINED, etc., that this Ordinance be filed in the records of Caddo Parish, Louisiana.

Collins and Hathaway 5. Nays: None.

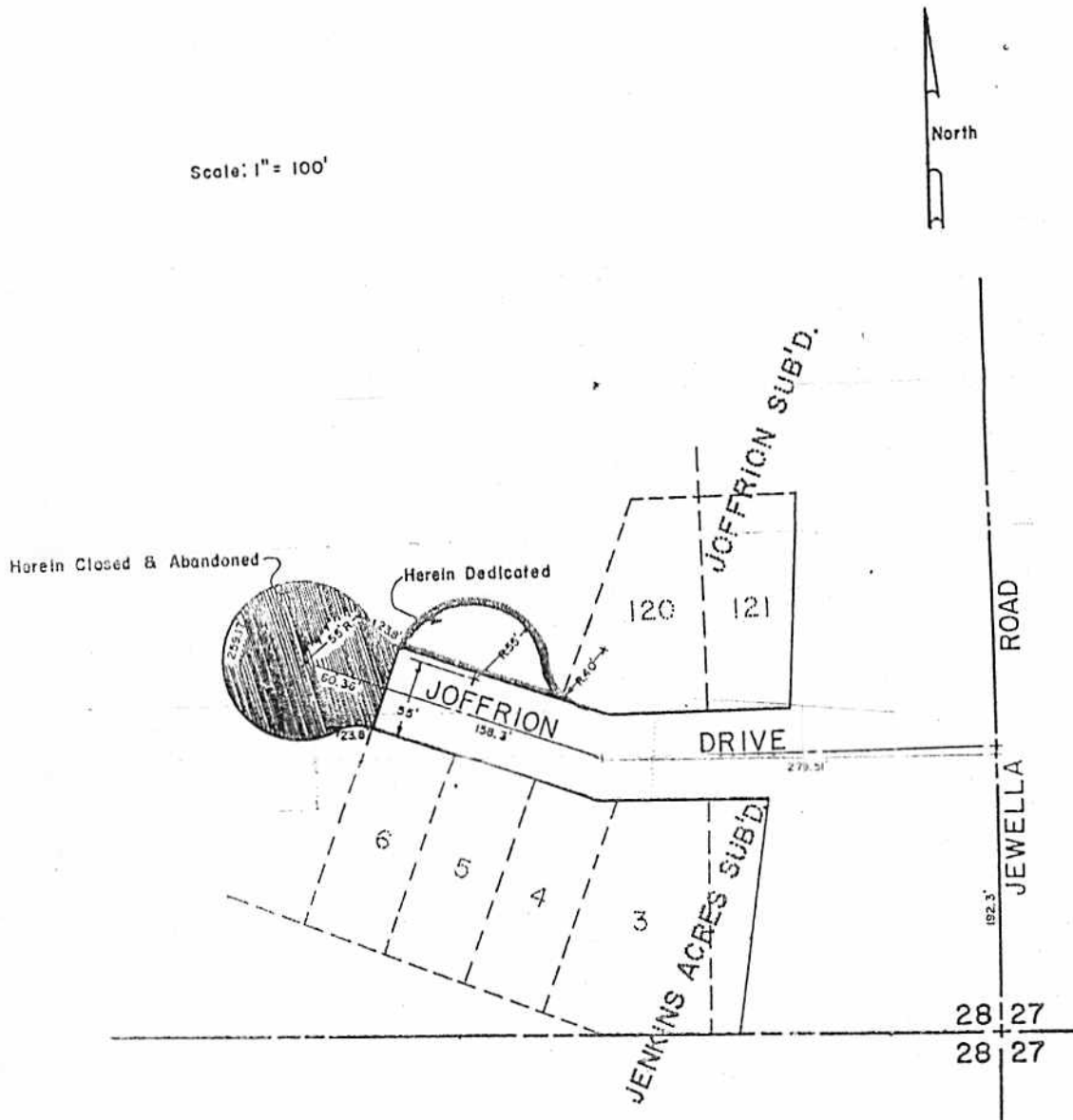
