

ORDINANCE NO. 72 OF 1972

BY MAYOR ALLEN

An ordinance amending Ordinance No. 33 of 1972 by including Lots 91 and 92 of the Shady Grove Subdivision, located on the North side of 86th Street, approximately 90 feet West of St. Vincent's Ave., and rezoning said lots from R-4, One-Family Residence District to B-3, Community Business District.

SECTION I: BE IT ORDAINED by the City Council of the City of Shreveport, Louisiana, in legal and regular session convened, that Section I of ordinance #33 of 1972, be and the same is hereby amended by including Lots 91 and 92 of the Shady Grove Subdivision, located on the North side of 86th Street, approximately 90 feet West of St. Vincent's Avenue, and changing the zoning classification of said lots from R-4, One-Family Residence District to B-3, Community Business District.

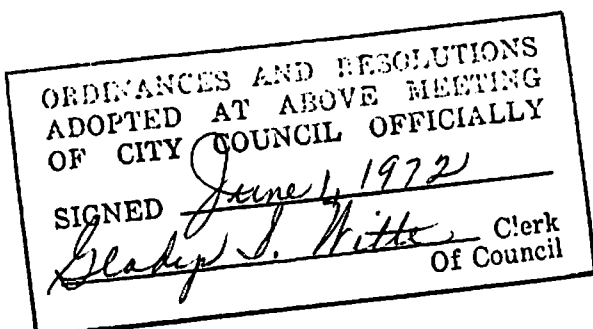
